

### Landing Fees

Landing fees apply to all turbine/jet aircraft. Landing fees apply to all piston aircraft with a registered gross weight of 3 tonnes or greater. All weights are determined by matching aircraft type with the weight listed in Transport Canada publication TP143, "**Air Traffic Designators**". Aircraft identified as "Trainer" or operators which advise the Airport Manager 7 days in advance of the call-sign/registration and date of training flight(s) and which completes 2 or more landings within a 60 minute period may receive a 75% discount on applicable fees.

### General Terminal Fee

The General Terminal fee applies to all flights utilizing the terminal or public apron facilities and aircraft with 8 seats or greater. For the purposes of this schedule, all aircraft with 8 seats or greater are determined to have used the terminal or public apron facilities, unless the aircraft is registered to an airport lease holder. The number of seats is determined by the certified maximum seating capacity for the aircraft type and does not include aircrew seats. Flights operated solely for the carriage of cargo can apply to the Airport Manager for an exemption. Non-scheduled aircraft operators wishing to report the actual number of passengers carried can participate in the Passenger Fee Schedule in lieu of the General Terminal Fee Schedule.

General Terminal Fee:  
 8 – 15 Seats - \$24.60  
 16 – 25 Seats - \$43.05  
 26 – 45 Seats - \$77.90

### Passenger Fees

The Passenger fee applies to all scheduled passenger flights or any other flight where the aircraft operator attests in writing to the number of passengers enplaned and/or deplaned within 7 days of the flight. A Passenger is defined as any person on board an aircraft, excluding active duty crew members and infants.

### Aircraft Parking Fees

Parking fees apply to all aircraft parked over 4 hours on aprons, ramps and tie-down areas.

Parking fees apply to all vehicles parked in airport parking lots and airport property.
