Methodology for Calculation of 2019 and 2020 Fees and Charges

Surcharges:

1. The E-Permit surcharge of 5% has been added to all fees contained in this Schedule.
2. Applicants requesting an "expedited" Development Permit (new construction or addition only), Compliance Certificate, Encroachment Agreement or Subdivision Application will be assessed a surcharge of 400%.
3. The Safety Codes Council (SCC) Fee of 4% will be added to all Building, Electrical, Heating, Gas, and Plumbing Permits. The minimum SCC fee is \$4.50 and the maximum is \$560.00. These charges are prescribed by the SCC and are subject to change. SCC fees do not apply to the double fee or a plan re-examination.

General Notes:

1. Applicants who dispute a fee may request a review by the General Manager of Planning & Development Services. The decision of the General Manager may be appealed to the Chief Administrative Officer (CAO). The decision of the CAO will be final and binding.
2. All fees listed above are GST exempt except where specifically noted.
